15. Adjournment and Closing Prayer: Chairperson

Our Parish Bylaws state that a member is in good standing and thereby eligible to vote at the Parish Assembly if he or she has submitted a stewardship commitment card and paid a proportionate share of his or her stewardship commitment through the quarter immediately preceding the Parish Assembly. Because our Parish will have been in existence for just over two months, or 1/6 of the year, at the time of the Parish Assembly, a member will be considered in good standing if he or she has submitted a stewardship commitment card and the portion donated is at least 1/6 of their annual commitment as of the date of the Parish Assembly.
