Notice of Special Parish Assembly – Saturday, February 14, 2015

Please take notice that a Special Parish Assembly will be held on Saturday, February 14, 2015, from 11:00 a.m. to 12:30 p.m. in the church of the St. Thomas More Catholic Church located at 3015 E. Creek Road (8000 S.) in Cottonwood Heights, Utah.

The sole purpose of the Special Parish Assembly will be to discuss the various facilities explored by the Real Estate Ministry Team and the Parish Council since the Fall Parish Assembly in November 2014, and to entertain appropriate motions to enter into a long term lease and make necessary facilities improvements with respect to available space located within the St. Thomas More campus. No other matters will be discussed and no other motions will be entertained.

Tours of the space available for our use on the St. Thomas More campus will be conducted from 10:00 a.m. to 11:00 a.m. on Saturday, February 14, 2015, for those wishing to see the facilities prior to the Special Parish Assembly.

Our Parish Bylaws state that a member is in good standing and thereby eligible to vote at the Special Parish Assembly if he or she has submitted a stewardship commitment card for 2015 and satisfied their stewardship obligation for 2014. Because our Parish did not exist until August 2014, members will be considered to have satisfied their stewardship obligation for 2014 if they paid at least 1/3 of their annual commitment for that year.
